Enrollment Fees

Enrollment fees are annual fees, due in March, for the upcoming school year. Payment plans are available. These fees are non-refundable. The fee is \$480 per student.

1 student - \$480 2 students - \$960 3 students - \$1,440 4 students-\$1,920

After School Fees for Those Who Use the Program

Registration is required for full time and drop in students. The registration fee is \$25 per family.

Drop in students pay \$20 per day per student. Full time students pay a flat weekly rate:

- \$75 per week (1 student)
- \$60 per week per student (2 students)
- \$50 per week per student (3+ students)

Tuition Assistance and Scholarship Opportunities

NC Opportunity Scholarship

The Opportunity Scholarship Program has expanded its reach. Starting with the 2024-25 school year:

- There is no income cap for families to receive the scholarship; all students in North Carolina in K-12th grade will be eligible for the scholarship regardless of income.
- Applicants no longer need to have been enrolled in a public school for eligibility
- A student's scholarship amount will be based on household income.
- Scholarship amounts will range from approximately \$3,000 to approximately \$7,000.

The priority application window for the 2024-25 school year is February 1-March 1. Awards are expected to be announced in April. We encourage all families to apply.

Black & Indian Mission Tuition Assistance for Students of African American & Native American Ancestry

Catholic school students (Preschool-12th grade) of African American Ancestry and Native American heritage in the Diocese of Raleigh are eligible to apply for tuition assistance.

Tuition assistance from Saint Peter Catholic Church

Tuition assistance is granted yearly for qualifying members of Saint Peter Catholic Church. Families must have documentation that they applied for and were denied the Opportunity Scholarship.

Using 529 Plans for Tuition at Saint Peter Catholic School

Qualified tuition plans can make nontaxable distributions for tuition at an elementary or secondary public, private, or religious school, up to \$10,000 incurred during each tax year, on a per-student basis.
